• State Government Levy (Bdlgov) is calculated by cost of construction X .00128. (GST not applicable). Payable if cost of works is over \$10,000.

• Council's Asset Protection Inspection Fee \$325 may be applicable depending on the type & cost of works, contact our Asset Department.

• Council's Approval Point of Discharge (APOD) Fee is **\$159.50**, contact our Drainage Department should you require an APOD.
